Mr. Ashraf Allam gave the Board a brief update on the Capital Project informing them that the District is moving right along and are on track. The state has approved the variances to move forward and we are looking into lighting upgrade options.

Mr. Joe Long informed the Board that Kindergarten registration was held last week and so far they have approximately 64 registered. Benton Hall had an unplanned fire drill this week caused by a heat sensor setting off the alarm. The Fire Department arrived and cleared the building rather quickly. He reported that both staff and students handled it great and evacuated quickly.
