SUPERINTENDENT'S REPORT

Mrs. Dooley had Kara Milianta, Sarah Barnes along with Alyssa Santos gave a brief presentation. Entrepreneurship and graphic design classes joined to create businesses. They created business plans to go along with their business which was an actual business that when they graduate they could continue with their business. They went with the idea of creating a food truck. They use life skills and are college ready and life ready when they leave here. Café Macaron – food truck/catering service presentation

Mrs. Lindsay gave a brief update regarding the Connected Community Schools. We have been meeting with different community groups/leaders. We are community with families in need which is why we are working together to save time and resources. We need to take care of our students needs before we focus on academics. We need our families to feel a connection. We want academics to become a priority. In order to do this we first need to identify families in need. From there we will create

family experiences at school. We will expand upon our already introduced literacy nights. We will provide childcare so parents can come and check things out. We would provide field trips based on curriculum. We need to create experiences so they can learn. We need to show our children what is out there beyond the city limits of Little Falls. We need to help them understand the diverse cultures within our Country. Community involvement would be us looking at doing beautification projects downtown and working with the Mayor and other business people in the city. To make this a reality we need a BOCES Coser for funding, a site coordinator, spaces to establish hubs, community partnerships, prioritize curriculum and writing grants. Ultimately, we are looking to create leaders for not only our school and community but also for our country.

Mr. Long –Informed the Board that he has Teacher assistants helping to get kids here and help with tutoring.

Mr. Tooley presented a high risk sports proposal provided by area Athletic Directors along with Public Health. This plan does have the support of Herkimer County Superintendents along with Herkimer County Public Health. The metric that we had to use in Herkimer County is a 14-day rolling average with 3 % or below for 14 consecutive days in order to begin anything. As of today, the data shows us at 5%. Our regions hospital capacity must be above 15%. We are proposing a 3 season model starting March 1st going basically until June 10<sup>th</sup>. Our first season would be boys/girls basketball from March 1st – April 10th and stay within Herkimer County BOCES component schools but including CVA. We are looking at Varsity and JV only. Modified would do skills/drills only. No spectators for indoor high risk sports. We would live broadcast sports. Masks would be worn by athletes, coaches and officials. We would not be using locker rooms. Second season which includes football, volleyball and sideline cheer would start April 5th -May 8th. The traditional spring season baseball, track, tennis and golf would start April 26<sup>th</sup> – June 11<sup>th</sup>. Spectators would be allowed and masks must be worn. Wrestling may be moved to spring as it is the riskiest. Dr. Grace is in support of this plan along with the County plan. Her only concerns are with wrestling. We can hold off on making a decision on wrestling for now since it wouldn't start until late April.

Approval is needed for basketball, volleyball, football, sideline cheer along with skills/drills. Off season conditioning would also be included in this approval.
